#### **COMPETITION ANNOUNCEMENT**

The Giovanni Bottesini Musical Association is pleased to announce the 6th International Double Bass Competition "Giovanni Bottesini". The Competition will take place in **Crema from April 18**<sup>th</sup> to **April 24**<sup>th</sup> 2017.

The competition is open to double bass players of all nationalities born after April 18th 1981.

The jury will compile a set of internal guidelines in order to establish the criteria to allow them to carry out their duties.

In the event of a tie, the Chairman of the Jury's vote will prevail.

Any member of the jury that is a relation/teacher of a competitor 2 years prior to the beginning of the competition, will not participate in the marking of the competitor.

The Jury's decision is final.

#### **Prizes**

First Prize "Walter Stauffer": study grant of € 10.000,00\* and an Adriano Massari bow

**Second Prize:** study grant of € 5.000,00 \* and an Emilio and Luca Slaviero bow

Third Prize: study grant of € 3.000,00 \* and an Marco Pasquino bow

\* The study grants will be paid out via bank transfer by the organisation within 60 days from the final.

The allocation of prizes is at the jury's discretion.

Competitors may be awarded equally shared prizes.

### Registration

Candidates that enroll in the competition must accept all of the rules and regulations of the competition.

All candidates must send the entry form, completed throughout, to the Competition secretary's office, no later than **February 28<sup>th</sup> 2017** and accompanied by the following:

- 1. a photocopy of a document attesting to the entrant's identity and nationality;
- 2. a recent photograph;
- 3. a short biography (in Italian or English), attesting to the studies completed, any prizes awarded in previous competitions and professional activity undertaken;
- 4. list of the pieces chosen from the program;
- 5. a scanned copy of bank transfer's receipt for the € 120.00 competition entry fee. Any transmission costs must be paid by the entrant. Payment of this fee will validate the entry, and may be conducted by means of a bank transfer to the current account of the Giovanni Bottesini Musical Association, held at the Crema branch of Banca Popolare,

The Competition will take place in Crema from April 18 <sup>th</sup> to April 24 <sup>th</sup> 2017 and will be divided into four stages:
a. First Round
b. Second Round
c. Third Round
d. Final Round
A detailed program of the competition days will be communicated at a future date.
The organisation will provide accommodation and meals to competitors who reach the semifinal of the Competition.
Musical Program

• The instrument must have a string length of at least 102cm.

- The candidate must play all of their chosen repertoire using solo tuning.
- The jury may decide to listen to the entire program, each piece or just an excerpt of the program or piece.
